This past year, Foundation donors supported the Hospital with over 29,500 gifts and with donations totaling \$7.1 million to advance health care in meaningful ways.

We are confident that we will continue endowment support to the Hospital, uninterrupted for the coming year. 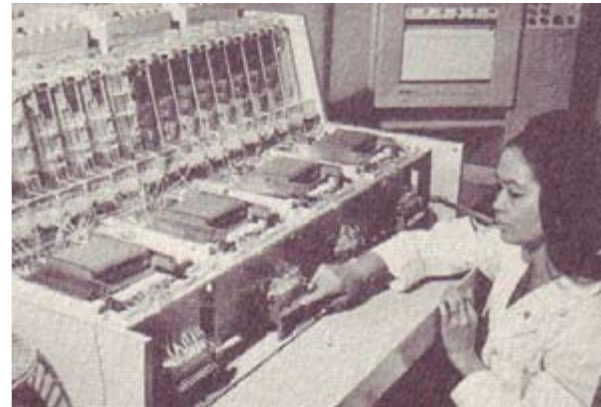
Your Gifts at Work

Donors continue providing vital support to the Hospital's programs. We have received a number of gifts, large and small that will greatly enhance the care we provide to our patients.

We rely on the community's support to fund life-saving diagnostic medical equipment and new technology such as automated medication dispensing units which significantly reduce medical errors, enhancing patient safety and ensuring patients get the right medication at the right time.

The **Karen, Heather and Lynn Steinberg Breast Services** will feature state-of-the-art digital mammography with tomosynthesis technology, the latest innovation in breast cancer screening and diagnosis, in both our *BMO Financial Group Breast Diagnostic Centre* and our Ontario Breast Screening Program site. They are slated to be operational in the fall.

Gulshan and Pyarali G. Nanji made a generous gift in support of medical imaging. The new **Gulshan & Pyarali G. Nanji Ultrasound and Radiography Centre** is already under construction and will open in Spring 2010.

Fundraising Highlights

In February 2009, North York General Hospital commenced construction of the **Volunteer Services Centre for Medical Imaging**. The wall-breaking event marked the beginning of the \$19.7 million project to provide the community with enhanced medical imaging, cardiac and neurological diagnostic services. The project includes a new Cardiac & Nuclear Imaging Suite, for which we are seeking to raise an additional \$2.5 million from the community.

In order to better serve our Jewish community and enhance awareness and cultural understanding, an interdisciplinary delegation from North York General Hospital visited Israel in June 2008 to share knowledge and experiences with Israel's health care teams.

Embracing Health Campaign

We continue to make considerable progress in the very early stages of our campaign. Under the leadership of Chris Tambakis, we have already raised more than \$16 million. These gifts are having a substantial impact on patient care by providing funding for the construction of the new *Volunteer Services Centre for Medical Imaging*, renovations to create a more child-friendly environment in the Child & Teen Unit, acquisition of a Capillary DNA Sequencer to help detect the gene that causes breast cancer and enabling the Hospital to initiate the first phase in establishing Electronic Health Records for patients.

This year, the \$50M campaign was formally named *Embracing Health* and has attracted the interest and involvement of many outstanding volunteers with a long history of dedication and commitment to North York General Hospital.



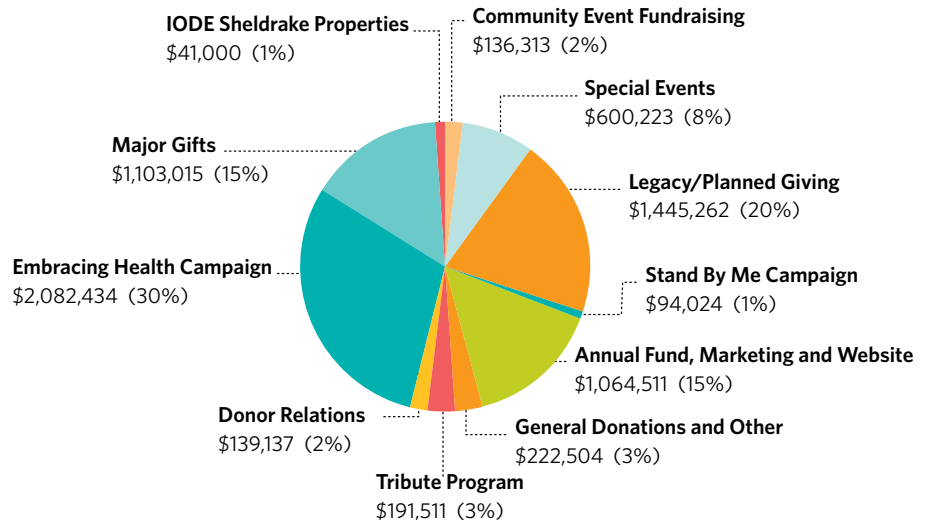

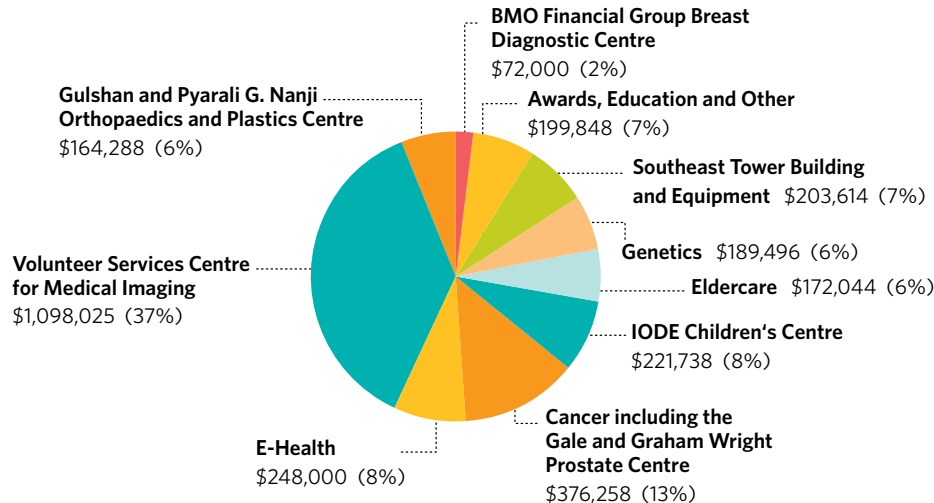
